It is for general information that as the existing panel of Para Legal Volunteers under the DLSA, Paschim Bardhaman is going to expire on 19/05/2025, a fresh panel as per the NALSA - Scheme of Para Legal Volunteers is required to be prepared and the existing panel of Para Legal Volunteers under the DLSA, Paschim Bardhaman will be invalidated after engagement of new PLVs through fresh panel.

All the PLVs of existing panel may make fresh application for their engagement afresh.

The District Legal Services Authority, Paschim Bardhaman is going to induct 19 nos. of Para Legal Volunteers(PLVs) for Paschim Bardhaman District. As such applications in standard form are invited from intending candidates of the following groups of people residing in Paschim Bardhaman District.

Teachers (including retired teachers)/ Retired Government servants and senior citizens / M.S.W Students and teachers / Anganwadi workers / Doctors / Physicans/ Students & Law Students (till they enroll as lawyers) / Members of Non-Political, Service oriented NGOs and Clubs / Members of Women Neighborhood Groups and other Self Help groups, Maitri Sangham and other Self Help Groups including marginalized / vulnerable groups / Educated prisoners with good behaviour, serving long term sentences in prisons/ Any other person whom the District Legal Services Authority deems fit to be identified as PLVs.

Note : Preference will be given to applicants who have residence / accommodation in the territorial jurisdiction of the following blocks.

Such Composition is made only to meet the requirement for covering the entire district for spreading out the activities of DLSA, Paschim Bardhaman.

Eligibility:

1. He / She must be a citizen of India.
2. He / She is not accused of any criminal Case.
3. The minimum age for the selection of Para legal Volunteers should not be less than 18 years as on the date of advertisement.

4. The candidate should have minimum qualification of Secondary from any recognized Board / University but preference shall be given to the candidates having Higher Secondary (10+2) with a capacity for overall comprehension who do not look up to the income they derive from their services as PLVs and who have a mind set to assist the needy in society coupled with the compassion, empathy and concern for the upliftment of the marginalized people and weaker sections of the society.

Note: The work of PLVs does not carry any Salary, Remuneration or Wages except the Honorarium as per existing Rules and Regulations of NALSA & SLISA, West Bengal (At present Rs. 750/- per day). Further, reasonable travel expenses may be reimbursed to PLVs on production of proof. The duties, function and remuneration of PLVs shall be governed by NALSA Scheme for Para Legal Volunteers and regulation in this regard from time to time.

Date and Place for submission of application :


The filled up prescribed application along with self-attested copies of certificates in respect of age, qualification, proof of residence along with work experience (if any) and photograph, should reach the office of the District Legal Services Authority, Paschim Bardhaman by 09/06/2025 upto 04-00 P.M. addressed to "The Chairman, District Legal Services Authority, Paschim Bardhaman". Address:- District Judges' Court Compound, Paschim Bardhaman, Pin-713304 either by Hand or by Speed Post. No other modes of communications shall be entertained.

Method of Selection:-

1. Incomplete applications will be rejected without assigning any reason. No application will be entertained after the last date fixed.
2. The selection of Para Legal Volunteers shall be made by the Selection Recruitment Committee of DLSA, Paschim Bardhaman and the candidates shall be selected through an interview / personality test.

Date of interview will be notified later in the official notice board of the District Legal Services Authority, Paschim Bardhaman as well as uploaded on the official website.

1. In case of any objection regarding enlistment of Para Legal Volunteers, the decision of the Selection / Recruitment Committee of DLSA, Paschim Bardhaman shall be final and binding on all concerned.
2. Canvassing directly or indirectly will disqualify the candidate.


